CURRENT PROJECTS

- A conference about the impact of the CHO project on the Lebanese economy is being hosted by the Faculty of Economics at the Saint Joseph University- USJ in Beirut, under the patronage of the Minister of Economy & Trade Mr. Mansour Bteich and with the participation of Prof. Jean Francois Goux, Professor Emeritus from Lyon Lumière 2 University in France and Dr. Samir Nasr, President of ECE Consultants on September 19, 2019.
- A revised version of the CHO Draft Law for Lebanon has been prepared to be submitted to Parliament.
- A discussion is taking place with the Central Bank of Lebanon and the Ministry of Finance, to delve more deeply into the advantages and risk mitigators of the project and ensure the adoption of the revised version of the Draft Law.
- Making in-depth presentations on a one-on-one basis with the remaining Members of Parliament, to get their support for the CHO Project & the Lebanese Draft Law.
